New version SHP- XBRL file allows either new style of Pan Card number or says user needs to enter ZZZZZ9999Z to validate the file along with reasons for not having correct format of pan card.

We are enclosed with a death certificate and PAN allotment letter from the income tax department. Also note that in our all earlier submission we have mentioned the same reason under the add notes tab for each promoter those who do not have valid pan numbers. The case is under process of Transmission at RTA agent and the will be transferred to legal heirs shortly.
